

I understand that the Department of Communications and the Arts has recently sought advice from the Telecommunications Industry Ombudsman on the status of outstanding COTS claims. I am advised that the Department of Communications and the Arts will respond to you directly on receipt of advice from the TIO.

Any evidence you have to support your claims of unlawful phone tapping and other improprieties should be forwarded to Senator Alston and the Australian Federal Police.
